

## Memorandum of Understanding

Between

(Young Indians)

And

(Hamlyn Shoes, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> January 2023 and sets for the terms and understanding between Young Indians and Hamlyn Shoes, Kolkata as mentioned in this MOU.

### Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.
