

Memorandum of Understanding

Between

(Young Indians)

And

(House of Pepe, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and House of Pepe, Kolkata as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, notfor-profit, industry led and industry managed organisation playing a proactive role in India's development process.

Yi was formed in the year 2002 with an objective of creating a platform for Young Indians to realize the dream of a developed nation. Yi has around 2800 direct members in 44 chapters, and engages around 18000 students through the brand 'YUVA'. The Yi membership includes young progressive Indians between the age group of 21 & 40 and comprises entrepreneurs, professionals and achievers from different walks of life. "To become the Voice of Young Indians Globally" being the vision of Yi, it provides a platform for young Indians to participate in and contribute by becoming an integral part of the Indian growth story. In the absence of mutual agreement by the authorized officials from House Of Pepe, this MOU shall end 31st December 2024.

This MOU shall be deemed to have come into force and effect as of the date of signing and shall remain in force till 31st December 2024 and may be further renewed by the parties upon mutually agreed terms and conditions.

This MOU is not a legally binding document' and serves only as a guideline of the terms of engagement mutually agreed to between the said partners. The said MOU shall in no form be legally enforceable and has no binding on either party/ partner involved in the same.

Offer:

- 1) Yi members will be entitled to 15% discount on play area, rock climbing, zipline spa salon and restaurant services upon presentation of membership card issued by Yi networks
- 2) This offer is valid only for members and not for the guests that accompany Yi members.
- 3) Bookings on weekends and public holidays - subject to availability only by prior bookings.
- 4) Validity:- upto 31/03/2024 subject to further extension.
- 5) The card is non-transferable meaning the member need to be present to avail the offer.
- 6) Rights of admission reserved.
- 7) We reserve the right to withdraw/revise our offer under unfortunate/ unforeseen circumstances with prior notice of 30 days.
- 8) Offer not valid for workshops and events hosted by HOP.
