

## Memorandum of Understanding

Between

And

(GOURMET VENTURE, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1<sup>st</sup> January 2023 and sets for the terms and understanding between Young Indians and GOURMET VENTURE, Kolkata as mentioned in this MOU.

### Introduction of Partners
