
Memorandum of Understanding

Between

And

(Medhavini Khaitan Menswear, Kolkata)

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and Medhavini Khaitan Menswear, Kolkata as mentioned in this MOU.

Introduction of Partners
