

Memorandum of Understanding

Between

This Memorandum of Understanding (MOU) is starting from 1st January 2023 and sets for the terms and understanding between Young Indians and PALM VILLAGE RESORT, Kolkata as mentioned in this MOU.

Introduction of Partners
