This Memorandum of Understanding (MOU) is starting from 1st April 2023 till 31st march 2024 and sets for the terms and understanding between Young Indians and Raajkutir IHCL , Kolkata as mentioned in this MOU.

Introduction of Partners

Young Indians (Yi) is an integral part of the Confederation of Indian Industry (CII), a nongovernment, not-for-profit, industry led and industry managed organisation playing a proactive role in India's development process.


